On Wednesday, the UK Court of Appeal ruled in the case of Meltwater & the PRCA vs. the Newspaper Licensing Agency (NLA) that copyright is extant in the copies of online work providing by an agency such as Meltwater to its clients. Background on the case can be found here, and the full judgment is online here. Meltwater and the PRCA intend to take their case further, by appealing to the UK Supreme Court, and are also currently awaiting a hearing in the Copyright Tribunal on the terms of the license agreed with the NLA. We think the time is right for #CommsChat to consider these issues by examining what communicators need to know about copyright, and what the legal implications are for both the online media monitoring services and their clients. We're delighted that Jorn Lyseggen, CEO of Meltwater, Richard Ellis, communications director at the PRCA, and Steve Kunczewicz, intellectual property, media and social media lawyer will be hosting today's #CommsChat. We asked the NLA if they would also like to act as guest hosts on this week's discussion, but managing director David Pugh is currently away. The main topics we'll be considering this evening are: - What does this judgment mean in the broad context beyond the specific case of Meltwater & the PRCA / NLA? Will there really be millions of copyright offenders as a result? - Does copyright now exist in headlines, or does it not? What is the thinking behind this decision? - Are we building towards wholesale reform of copyright legislation in the UK? - Is this ruling a positive or a negative for the UK business community as a whole? Would the reform of copyright legislation enable the UK to attract more web-based businesses in the early stages of their development? - What does this ruling mean for the agencies and communications specialists that currently use services such as Meltwater to monitor online media? - Can legislative processes ever really keep up to speed with the information age? #CommsChat will kick off at 8pm BST.
